SUMMARY:

Performs skilled and semi-skilled work at the journeyman level in the installation, construction, repair, operation and maintenance of wastewater treatment facilities. Supervises subordinate operators in the daily operations at the wastewater treatment plant. Works with the Superintendent to ensure the facilities are in compliance with all applicable rules and regulations.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Performs skilled work in the operation of the wastewater treatment plant including plant laboratory.
- Determine system changes to maintain quality control standards.
- Maintains and repairs pumps, valves, and bar screen.
- Measures and records oxygen levels in aeration basins.
- Operates and maintains clarifier, scum box and related equipment.
- Maintain UV system operation for compliance with NPDES permit requirements
- Removes bio solids from sludge lagoons.
- Monitors effluent flow to different locations.
- Maintains records and files on plant operation and equipment maintenance.
- Enters plant operation data in a computer database.
- Performs maintenance of outside grounds areas around the plant.
- Collects samples, runs laboratory tests.
- Performs building custodial care in the plant.
- May provide relief work at the Wastewater Plant on an ON-CALL basis if required.
- May assist Wastewater Superintendent in evaluation of subordinate operators.
- May be required to prepare or assist in preparation of reports to governmental agencies.
- Ensure that maintenance program schedule is being followed and updated
- Enter all daily operations performed into the Daily Log in detail
- Performs related duties as assigned.

MINIMUM QUALIFICATIONS, EDUCATION, AND EXPERIENCE:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- High school diploma or general education degree (GED); one year experience as a Wastewater Treatment Plant Operator or Operator In Training or equivalent combination of education and experience.
- Read, understand, and practice safety procedures in plant operations.

- Implement principles and practices necessary in wastewater plant operations.
- Perform repairs and adjustments to motors, pumps, and other equipment.
- Read meters and gauges correctly and to respond to unusual situations quickly and competently.
- Collect samples and perform laboratory tests.
- Operate backhoe, trucks and tractors.
- Prioritize and schedule work.
- Meet schedules and time lines.
- Maintain up to date knowledge of regulations.
- Establish, maintain effective relationships.
- Operate a computer and related software.

PREFERRED QUALIFICATIONS AND EXPERIENCE:

Knowledge of:

- Functions and purposes of wastewater treatment systems.
- Basic mechanical and electrical systems.
- Safe work practices
- Working around UV systems, electricity and chemicals.
- Goals, policies and objectives of wastewater treatment plant operations.
- Oral and written communication.
- Chemistry and math.
- Operation of computers and related software.
- Policies and objectives of assigned programs.
- Operation of heavy equipment around the plant grounds.
- Collection and testing of samples.
- Chemical applications for wastewater treatment.
- College level course work or trade school training in mechanical repair, wastewater treatment technology, or a related field is highly desirable.

CERTIFICATES, LICENSES, REGISTRATIONS:

- Valid California driver's license.
- Grade III Wastewater Treatment Plant Operator Certificate issued by the State Water Resources Control Board.

Every individual holding this position must possess and maintain all certificates, licenses and registrations required by law at the current time or in the future.

PHYSICAL DEMANDS:

- Sitting, standing, stooping, walking, climbing, grasping, lifting, manual dexterity, clear speech, clear hearing, clear seeing and driving.
- Required to climb or balance and perform work which involves lifting, pushing and/or pulling of objects which approximate 75 pounds.
