

## RESOLUTION CC 2025-70

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHASTA LAKE INITIATING THE PROPOSITION 218 NOTIFICATION AND PROTEST PROCESS FOR PROPOSED SOLID WASTE RATE ADJUSTMENTS AND SETTING THE PUBLIC HEARING DATE FOR DECEMBER 16, 2025

---

**WHEREAS**, the City of Shasta Lake (“City”) provides solid waste collection services to its residents and businesses under the authority of Section 13.16 of the Shasta Lake Municipal Code, through a franchise agreement with USA Waste of California, Inc. (Waste Management – WM); and

**WHEREAS**, under this franchise agreement, WM provides for the collection, transfer, processing, and disposal of all solid waste, recyclables, and organic waste generated within the City; and

**WHEREAS**, the City’s franchise agreement establishes the initial rate structure and provides an inflation-based formula for annual rate adjustments to reflect changes in the Consumer Price Index (CPI) and increases in disposal and operational costs; and

**WHEREAS**, the proposed rate adjustments include new costs associated with compliance with State-mandated organic waste diversion requirements under Senate Bill (SB) 1383 (2016), which requires all jurisdictions to implement organic waste collection and processing programs to achieve a 75% reduction in landfilled organic waste by 2025; and

**WHEREAS**, Article XIII D, Section 6 of the California Constitution (Proposition 218) and Government Code Section 53755 require that property-related fee and rate increases, such as solid waste collection charges, be subject to mailed notice and a public hearing process, with the opportunity for affected property owners and customers to file written protests; and

**WHEREAS**, the City Council desires to initiate the Proposition 218 notification and protest process to consider the proposed solid waste rate adjustments and to set a public hearing date to receive public input and determine whether a majority protest exists; and

**WHEREAS**, notices will be mailed to all affected customers at least forty-five (45) days’ notice prior to the public hearing, as required by law.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Shasta Lake as follows:

1. The City Council hereby initiates the Proposition 218 notification and protest process for proposed solid waste rate adjustments, as detailed in the accompanying staff report and Exhibit A (Proposed Rates).

2. The City Council hereby sets Tuesday, December 16, 2025, at 6:00 p.m. (or as soon thereafter as the matter may be heard) at the Shasta Lake City Council Chambers, 4477 Main Street, Shasta Lake, California, as the date, time, and place for the Public Hearing on the proposed rate adjustments.
3. The City Manager, or her designee, is authorized to prepare, publish, and mail the Proposition 218 notices in compliance with State law and City procedures.
4. Following the conclusion of the protest hearing, if no majority protest exists, the City Council may consider adoption of the proposed solid waste rate schedule.
